- 4. The school is required to construct the partition in girls and boys urinals and may remove the green matt laid on the floors as it is unhygienic for the students within 03 months and submit the compliance.
- 5. The school shall conduct training of its teachers with COE Bhubaneswar within 3 months and submit the compliance.
- 6. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time
